RE: NOTICE OF INTETION TO ALL TOUR OPERATORS.

The heading above is concerned.

Ngorongoro District Council is pleased to inform all Tour Operators/Hotels/Camps Owners regarding an intention notice of the council for collecting tourism fees at all entrance gates in Ngorongoro district as the part of council revenue sources.

Tourism is the major source of revenues of Ngorongoro District Council by more than 80% of Council own source annual budget. However, the District Council is benefiting little from potentials of tourism in the District compared to diversity of tourism potentials/attractions in the district like Ngorongoro Conservation Area, Lake Natron and Loliondo Game Controlled Areas. Unfortunately, the whole areas of the district are protected which limits others social economic activities like cultivation, buildings and business that can be used as council revenue sources especially at Ngorongoro Conservation Area and Lake Natron Basin. Due to this situation the council, is in hard time to run council administrative responsibilities and execute developments to local communities as a principal role of the council.

As you aware, Ngorongoro district Council over many years and now is collecting tourism fees at Engarasero-Lake Natron and Klein's TANAPA gates-Ololosokwan, but the revenues accrued from these gates are very small just 2% of all tourists entering the district through Loduare gate-NCA which is estimated to receive more than 600,000 tourists per year.

Therefore, according to the meeting of Council outstanding committee responsible for finance and planning being conferred power by District Council Meeting has approved the notice of intention of collecting tourism fees at Loduare-NCA, Golini, Pinyinyi, Kakesio and Enguserosambu gates with the similar price of Engarasero and Kleins gates. Also, these charges are single entry and there are only paid once to pass any of the gates mentioned above. Fees payable at District gates will be effective from 1st October, 2021 as follows;
